Instructions to Authors -- Nihon Reoroji Gakkaishi-- (2017 July)

Nihon Reoroji Gakkaishi (J Soc Rheol, Jpn) accepts contributions in rheology and related technology. Contributions may be submitted as Original Articles, Feature Articles, Rapid Communications, Notes or Reviews. Papers from new emerging areas of the field are particularly welcome. Authors are requested to submit their original manuscript and figures plus a copy to the Editorial Board of the Society of Rheology, Japan, 3F, Bldg. No.6, Kyoto Research Park, 93, Chudoji-Awata, Shimogyo-ku, Kyoto 600-8815, Japan. Authors may submit the PDF file of their original manuscript to the Editorial Board of the Society of Rheology, Japan, (journal@srj.or.jp) via e-mail as an attached file.

If revision of the original manuscript is required, authors will have a maximum of four months (from receipt of the referees comments) to revise and re-submit. A revised manuscript received by the Editor later than four months after the authors receipt of the referees comments will be treated as a new submission.

Original Articles are full-length to be considered as complete publication of original unpublished results within 6 printed pages. A short synopsis (maximum length 200 words) is required for original articles. The synopsis should be a summary of the entire paper, not the conclusions alone.

Feature Articles are publications summarizing a superior achievement by a research group related to rheology presented within 8 printed pages.

Rapid Communications should be preliminary reports of unusual urgency, significance, and interest presented within 2 printed pages. Authors submitting the reports should clearly identify them as such and explain why they merit rapid publication. Synopsis is not required.

Notes are publications of original unpublished results shorter than original articles within 2 printed pages. They should include unexpected or novel results and technologies related to rheology.

Reviews are usually invited by the Editors.

Copyright is transferred to the publisher when a manuscript is accepted for publication. Although this journal does not carry a page charge for contribution, authors will be asked to purchase at least 50 reprints.

Manuscript Preparation

Manuscript should be typed double space throughout and on one side of each sheet only, on a heavy grade white paper $(22 \times 28 \text{ cm})$ or A4) with margins at least 2.5 cm on all sides. High quality printouts with a font size of 12 pt are required. All pages should be numbered consecutively. The order of the manuscripts should be title, author(s) and full affiliation(s), abstract, keywords (within 5 words), main text, references, tables, figure legends (or captions), schemes, and figures. Sequences of tables, charts, and schemes should be numbered with Arabic numerals. After final acceptance, manuscript should be submitted together with the electronic files of article and original hard copies of figures.

The main text should include introduction, theory, experimental section, results, discussion and conclusion. Headings and subheadings for different sections of the papers should be used and clearly identified. If each section needs to be numbered, a sequence such as 2., 2.1., 2.1.1., etc should be used. Figures or tables should not be imbedded in the text.

Authors are cautioned to type all mathematical and chemical symbols, equations, and formulas. All Greek or unusual symbols should be identified in the margin the first time they appear. Vectors and tensors should be set in boldface italic. Symbols for scalar quantities should be set in italic. Equation should be numbered consecutively with Arabic numerals in parentheses on the right-hand side of the page. All measurements and data should be given in SI units.

The format of reference must be uniform and consistent with those found in a typical issue of Journal of the Society of Rheology, Japan. They should be numbered consecutively in the order of their appearance. All publications cited in the text should be presented in a list of references following the text of the manuscript. Abbreviations of journal titles should be conformed to the practice of Chemical Abstracts. Note the following examples:

Original drawings and photographs should be attached separately to the original manuscript and should be clearly marked on the back with the figure number and author(s) name. Color reproduction is available if the author is willing to bear the additional incremental reproduction and printing cost. The author(s) should indicate by text or marginal notations in the typescript where the figures are approximately to be inserted.
